The public KS-CPOST Commission meeting was held via teleconference and was called to order by Chairman John Whitmer with a roll call of commissioners in attendance as listed above. KS-CPOST and KLETC above.

Approval of minutes

A motion (2017 M 01) was made by Commissioner Schoen to amend the December 7, 2016 Minutes by inserting the names of Commissioner Thompson, Commissioner Mellor and Commissioner Bruce into the paragraph defining Motion 2016 M 13, authorizing these Commissioners to review any initial order issued by the Kansas Office of Administrative Hearings. The motion was seconded by Commissioner Whitmer and passed unanimously.

Commissioner Herrig made the motion (2017 M 02) to approve the amended Minutes from the December 7, 2016 KS-CPOST Commission Meeting. The motion was seconded by Commissioner Jones and passed unanimously.

A motion (2017 M 03) to approve K.A.R. 106 2-4 Good Moral Character and instruct staff to pursue it at their earliest convenience was made by Commissioner Schoen and seconded by Commissioner Whitmer. The motion passed with Commissioner Bundy casting a no vote.

Commissioner Whitmer made a motion (2017 M 04) to permit the Chairman at the appropriate time, or the chair's designee, to schedule a Public Hearing, at the appropriate time, on the proposed amendment to K.A.R. 106-2-4, Good Moral Character, following the necessary approvals and to call a meeting for that purpose and to serve as a Hearing Officer at that Public Hearing. Commissioner Schoen seconded the motion and it passed unanimously.

Upon motion (2017 M 05) made by Commissioner Herrig and seconded by Commissioner Jones, the meeting was adjourned at 9:32 am by a unanimous approval.
